NR351 Week 4 Professional Paper Worksheet assignment enables you to demonstrate your ability to organize, utilize resources, and apply APA formatting skills when [online custom writing services](#) paper. Please read the instructions and rubric carefully.

Locate the scholarly article linked in the announcement and review it. Create a 10-25 word quotation from the article, using correct APA citation including quotation marks, authors' names, year, and page numbers.

## Citations

The MLA or Modern Language Association style is a research paper format often used in humanities and liberal arts subjects. This style requires the use of a reference list and in-text citations. The reference list cites the surname of the authors and publication date while the in-text citation provides the author's last name and page number for direct quotations. The format of this type of writing [Professional Paper worksheet assignment](#) depending on the type of source being cited.

## NR351 Professional Paper Worksheet Assignment Instructions and Template

Read the assigned article in the Hood textbook for your topic from this week's announcement; and create a reference in APA format for the article using the instructions and specifics of the Template and rubric. Develop a comprehensive outline for your upcoming Professional Paper including an introduction, two main topics, and conclusion (with excellent subtopics as required on the Template). Ensure that your template is complete; and follow all guidelines for references, citations, quotations, and paraphrasing.

## Paraphrasing

In writing, paraphrasing is a key skill to develop. It allows you to write in your own words, but maintain the original meaning of the author's ideas and words. It is often preferred to direct quotes in academic papers. However, you should be careful not to cross the line into plagiarism. If you have difficulty with paraphrasing, try taking abbreviated notes; set the notes aside for a few hours or days; and then [NR439 Week 3](#) them in your own words. This strategy can help you to internalize the author's thoughts and words, which is necessary for effective paraphrasing.

Many published authors paraphrase more than they quote, which allows them to focus on important information and to keep the flow of their writing intact. Regardless of whether you quote or paraphrase, be sure to include in-text citations and full references at the end of your paper.

## References

When using quotes, paraphrases, or ideas from other sources in your NR351 Professional Paper, it is important to cite them properly. Citing your sources helps you avoid plagiarism, which is a serious academic offense. It also lets readers find the information they need.

The citation should include the author's name, a period after it, and the article title in italics. This is a standard format for all citations, whether they are standalone [NR 447 Week 3 Conflict Resolution Paper](#) or part of bigger works like books and journals.

Read the assigned article for your Professional Paper topic (see announcement in Doc Sharing). Select a 10-25-word quotation from that article and create a reference in APA format for it. Also, type an appropriately paraphrased version of the words cited in that section. Use the correct APA citation including authors' names, year, and parentheses. If possible, add a DOI. Clearly state the page number in the reference.
